ALL PAST DUE accounts (unpaid 30 days beyond the month of purchase) are subject to FINANCE CHARGE of 1 ½ % per month (18% annual) except where limited by state statutes.
3. All payments will be applied to oldest balance unless otherwise specified.
4. Accounts with Accounts Receivable(A/R) reater than(>) 20 days can receive nitrogen, gloves, and sheaths only. Any other purchases can be made only if acceptable payments (as determined by Marketing Director and Finance Director)are being made. Full payment of balance> 120 days(at minimum) will allow continuation of all sales and service at any time.
5. Accounts with A/R>90 days will get letter indicating the above.
6. Any accounts >180 days non payment will become the property of **Champion Genetics, Inc.**
